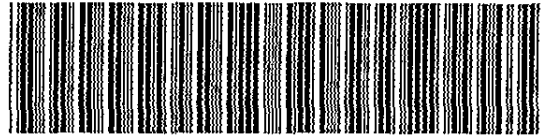

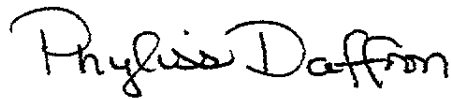

The term of existence of the corporation is perpetual.

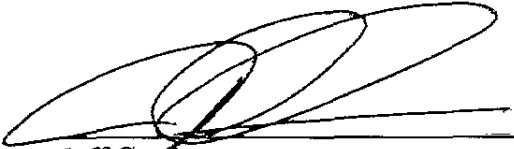
**ARTICLE SEVEN**
