## Certificate of Incorporation TARY OF S

Of ATM INVESTORS INC.
We, the undersigned, hereby associated ourselves together for the purpose of becoming a corpo ration under the laws of the State of Florida by and under the provisions of the statutes of the State of Florida, providing for the formation, rights, privileges, immunities and liabilities of incorporation for profit.
The name of the corporation shall be: A T M INVESTORS INC.
Article II  The corporation will engage in any activity or business permitted under the laws of the State of Florida and of the United States of America.
