

ARTICLES OF INCORPORATION

OF

OM SAI RAM, INC.

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I -- NAME OF CORPORATION

The name of this corporation is **OM SAI RAM, INC.** and its principal place of business shall be located at 4201 Bryan Street, Greenwood, Florida 32443-2425.

ARTICLE II - TERM OF EXISTENCE
