ARTICLE I. CORPORATE NAME

The name of this Corporation is Todd A. Weaver, PA.

ARTICLE II. CORPORATE PRINCIPAL OFFICE AND MAILING ADDRESS

The Corporation principal office and mailing 43 Pinewood Circle, Safety Harbor, FL 34695.

ARTICLE III. NATURE OF BUSINESS
