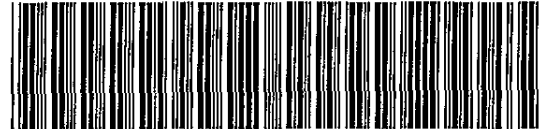

outstanding

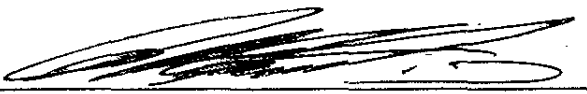

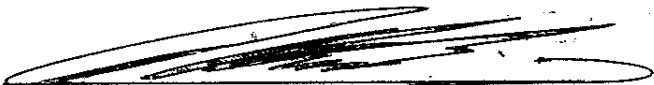
