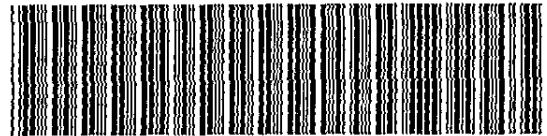

# Articles of Incorporation of

- FIRST: The name of the corporation is M T M S, INC.
- SECOND: The period of its duration is Perpetual
