
### **Amendment**

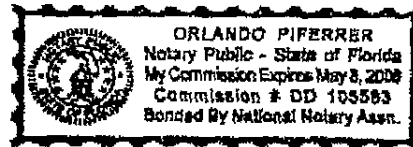
