# ARTICLES OF INCORPORATION OF PRIME ASSETS INTERNATIONAL CORPORATION

SECRETARY OF STARLED

The undersigned subscriber to these Articles of Incorporation is a natural person competent to confract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

# **ARTICLE 1 - NAME**

- 7.4 The Board of Director(s) of the Corporation may, by Restated Articles of Incorporation, classify or reclassify any unissued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of the stock.

# ARTICLE 8 - SHAREHOLDERS' RESTRICTIVE AGREEMENT

All of the shares of stock of this Corporation may be subject to a Shareholders' Restrictive Agreement containing numerous restrictions on the rights of shareholders of the Corporation and transferability of the shares of stock of the Corporation.
