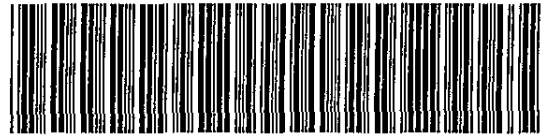



OF

ARTICLE I. CORPORATE NAME

The name of this corporation is: JEFF LAMM, INC., and the street address and mailing address of the principal office of this corporation is 208 S. Habana Avenue, Apt. E, Tampa, Florida 33609.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK


