**ARTICLES OF INCORPORATION
OF
AIRLIFT HELICOPTER TRAINING, INC.**

ARTICLE II - NAME OF CORPORATION

The name of this corporation is AIRLIFT HELICOPTER TRAINING, INC.

ARTICLE II - PURPOSES

This corporation is organized for the purpose of transacting any or all lawful business pursuant to the provisions of Chapter 607, Florida Statutes.

ARTICLE III - CAPITAL STOCK

The maximum number of shares this corporation is authorized to issue is 7,000 shares of common stock, each having a par value of \$1.00. 




