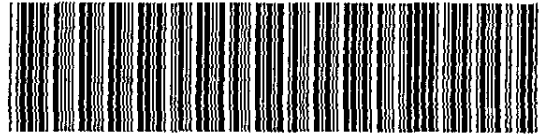

The name of this corporation: **FLORIDA SUNSHINE INSPECTIONS, INC.**


