ARTICLES OF INCORPORATION

OF

The undersigned incorporator, being competent to contract, subscribes to these Articles of Incorporation to form a professional service corporation for profit pursuant to Chapter 627 and Chapter 607 of the Florida Statutes.

ARTICLE I - Name

The name of the corporation shall be:
