ARTICLE XIII

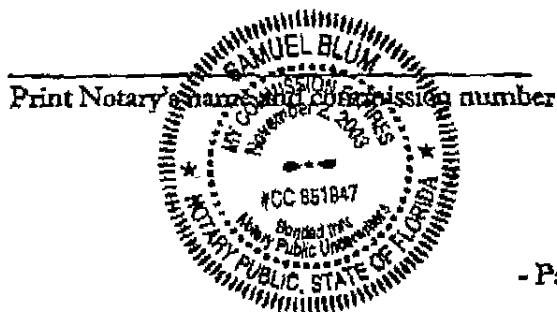


