ARTICLE VIII

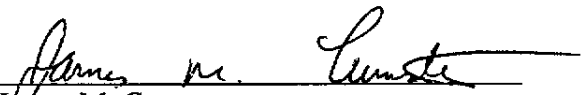
BY-LAWS
