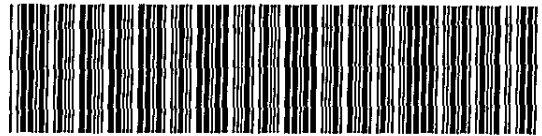

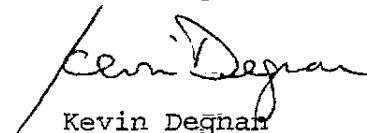

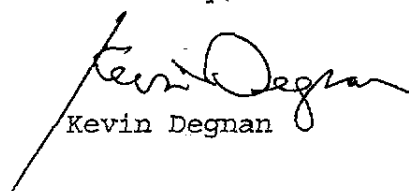

BY THESE ARTICLES OF INCORPORATION the incorporator forms a <sup>STATE</sup> ~~ALL~~ corporation for profit under Florida law.

ARTICLE 1

The name of the corporation is FIRST SAGICOR SERVICES, INC.

The corporation shall exist perpetually.

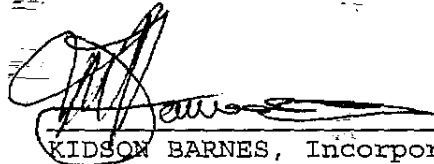

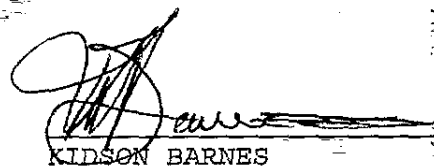
