In compliance with Chapter 607, Florida Statutes (Profit), the undersigned, who is a resident of Florida and is of full age, has this day, for the purpose of forming a for profit corporations, voluntarily certifies:

**ARTICLE I**

The name of the corporation is: Monique K. Meadows, P.A.

**ARTICLE II**

The principal place of business/ mailing address of the corporation is: 3681 Marsh Park Ct, Jacksonville, FL 32250.

**ARTICLE III**

ARTICLE VII

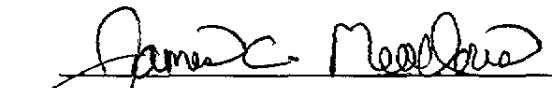

The duration of the corporate existence shall be perpetual.

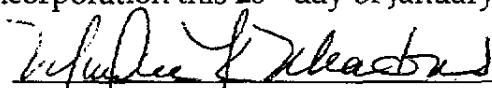
