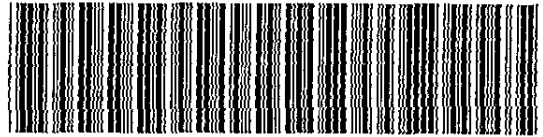



ARTICLES OF INCORPORATION

OF




