
RE: Annual Report

Dear Div. of Corp.:

Due to the Hurricanes that hit our are last year, we ended up closing the retail part of the business in March and we moved to Pensacola and are not opening a store. I actually thought I had paid the \$150.00 before May 1, so I don't know what happened—must have got lost in the move.

We have actually been doing Volunteer Hurricane Relief work since Charlie hit Punta Gorda and Ivan hit Pensacola. We did relief work in Milton and Pace after Dennis hit in July and after Katrina hit. Since Sept. 1 we have been doing volunteer hurricane relief in Gulfport, MS 5 days a week and trying to work secularly 2 days a week, but in Oct. only worked 1 day secularly and in November we were sick 2 different weeks with a respiratory infection and one week with GI Flu. We have only been home to get bills and take care of business here twice. Please excuse the lateness of this payment and reinstate our Corp. without interruption. We appreciate you cooperation in this matter.
