Name and Address of Corporation

The name of this corporation shall be PARMAT GROUP, INC. The principal place of business and address is 652 SW 168 Terrace, Pembroke Pines, Florida, 33027.



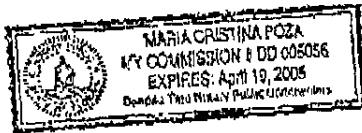
