## ARTICLES OF INCORPORATION OF:

## BRAZILIAN MEAT MARKET, INC.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

#### <u>ARTICLE I - NAME</u>

The name of this corporation is BRAZILIAN MEAT MARKET, INC. (Hereinafter, "Corporation").
