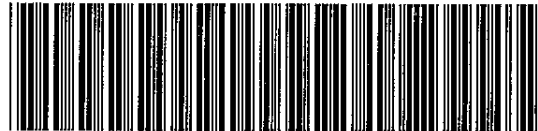

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is **MOJADIDI HEALTH CARE SERVICES, P.A.** The specific nature of business is to offer chiropractic services,

ARTICLE II

The existence of the Corporation shall begin on the date on which these articles are filed with the Secretary of State.

ARTICLE III

The street address of the principal office of the Corporation is 6501 Arlington Expressway, Suite A-106, Jacksonville, Florida,

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, par value One Dollar (\$1.00) per share, all of which shall be Common Shares.
