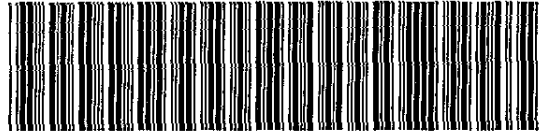

ARTICLES OF INCORPORATION  
OF  
CARIBBEAN ARTWORKS, INC.

The undersigned, acting as Incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I-NAME

The name of the corporation shall be CARIBBEAN ARTWORKS, INC.

ARTICLE II-PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 1002 Windmill Grove Circle, Orlando, Florida 32828.

ARTICLE III-DATE OF EXISTENCE

This corporation shall exist perpetually, commencing on the date of execution of these Articles of Incorporation.

ARTICLE IV-INDEMNIFICATION

This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

Copies of any stock restriction agreement between this Corporation and its shareholders shall be maintained at the principal office of this Corporation.


