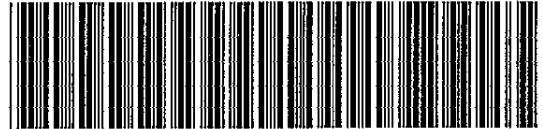

The name of this corporation is MILENIUM IMAGE SERVICE, CORP.

This corporation shall begin its corporate existence on the day these articles are filed with the State of Florida, Secretary of State.


ARTICLE IX - BY-LAWS



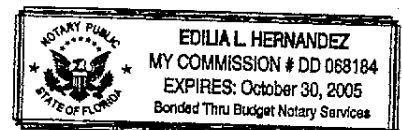
