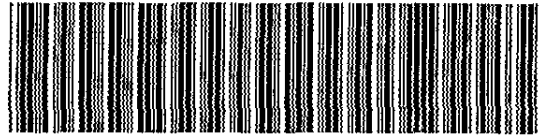


#### ARTICLE VIII. PRIVATE PROPERTY
