ARTICLES OF INCORPORATION
OF
LOU'S LITTLE JOBS, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the Corporation ("Corporation") is LOU'S LITTLE JOBS, INC.

ARTICLE II - PRINCIPAL OFFICE

The street address of the principal office of the Corporation is 32229 Hartman Road, San Antonio, Florida 33576, and the mailing address is Post Office Box 220, San Antonio, Florida 33576-0220.

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - SHARES

The maximum number of shares this Corporation is authorized to issue is 7,500, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V - REGISTERED AGENT

The initial street address of the Corporation's registered office is 32229 Hartman Road, San Antonio, 33576. The initial registered agent for the Corporation at that address is LOUIS JOHN RINALDI.

ARTICLE VI- BOARD OF DIRECTORS
