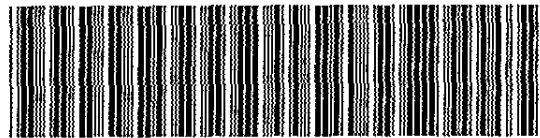

Article I - NAME .

The name of the corporation is ^{h W} **H W Gossop Company Inc.**

Article II - PRINCIPAL OFFICE.

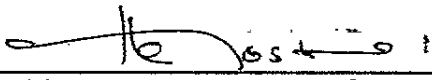
