# ARTICLES OF INCORPORATION OF WL WYNN CONSULTING, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida adopts the following Articles of Incorporation.

# ARTICLE I

# NAME AND ADDRESS

WFERTINE DATE

- Section 1.1 Name. The name of the corporation is WL Wynn Consulting, Inc.
- Section 1.2 <u>Address</u>. The principal office and mailing address of the corporation shall be 545 Lakefield Lane, Orange Park, Florida 32073.

# ARTICLE II

### **DURATION**

Section 2.1 <u>Duration</u>. This corporation shall exist perpetually.
