ARTICLES OF INCORPORATION OF

Ashby's Cafe, Inc.ARTICLE 1. - NAME

The name of this corporation is Ashby's Cafe, Inc..

ARTICLE 2. - PRINCIPAL OFFICE; MAILING ADDRESS

The principal office of the corporation is initially 1540 Palm Brush Trail, Bradenton, FL 34202 and the mailing address of the corporation is initially 1540 Palm Brush Trail, Bradenton, FL 34202. The corporation may change its principal office and/or mailing address from time to time as permitted by law.

ARTICLE 3. - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.




