ARTICLES OF INCORPORATION OF
ELLIOTTE SERVICES, INC.

1. Name. The name of the corporation is: ELLIOTTE SERVICES, INC.
2. Purpose. The corporation may engage in any legal business.
3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1000 shares of common capital stock with no par value.
