The undersigned, Mark Sustana, being a duly elected Vice President of LENNAR-KINGS LAKE, INC., a Florida corporation (the "Corporation"), hereby states as follows on behalf of the Corporation:

Pursuant to the requirements of Sections 607.1006 and 607.1007 of the Florida Business Corporation Act, the undersigned hereby certifies, attests and serves notice that the Articles of the Corporation are hereby amended and restated in their entirety to read as follows effective as of 12:01 A.M., on June 21, 2006, which Amended and Restated Articles of Incorporation incorporate an amendment to Article VII of the Articles of the Corporation:

ARTICLE I -- NAME
