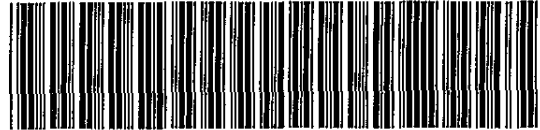

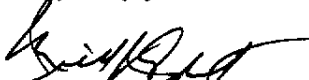

**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation:

**Article I.-Name of Corporation**

The name of the Corporation shall be Lake Mary Walk-In Medical Center, Inc.

**Article II.-Principal Office**

The principal office of this Corporation shall be located at 870 S. Sun Drive, Suite 1030, Lake Mary, Florida 32746.

**Article III.-Term of Existence**

The Corporation shall commence on the date of execution of these Articles of Incorporation and shall have perpetual existence.

**Article IV.-Capital Stock**

The maximum number of shares of capital stock which this Corporation shall be authorized to issue is 1,000 shares of common stock having a par value of \$1.00 per share.

**Article V.-Initial Registered Office and Registered Agent**

The initial street address of the registered office of the Corporation is 3117 Edgewater Drive, Orlando, Florida 32804. The name of the initial registered agent of the Corporation is Michael J. Appleton. The Board of Directors may from time to time move

the registered office to any other address within the State of Florida and may designate a new registered agent.

#### **Article VI.-Incorporator**

#### **Article VII.-Initial Board of Directors**

The initial number of directors of the Corporation shall be one (1). The Corporation shall indemnify any officer or director, and any former officer or director, to the full extent permitted by law.
