**ARTICLES OF INCORPORATION
OF
A- LiBline COMPANY, INC.**

In compliance with requirements of F.S. Chapter 607, the Undersigned, being a natural person, does hereby act as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is A- LiBline COMPANY, INC.

ARTICLE II

The street address of the principal office of the Corporation is: 10030 SW 127 AVE.
Miami, FL 33186.

ARTICLE III

The purpose for which the corporation is organized is: Imports/Exports, Manufacturing, Distribution, Graphic Design, Marine, The construction, repair and remodeling of buildings and public works of all kinds, and in the improvement of real state, and the doing of any other business and contracting work incidental to or connected to such work, including demolition. The foregoing purposes and activities will be interpreted as examples only and not limitations, and nothing therein shall be deemed as prohibiting the corporation from engaging in any lawful act or activity for which a corporation may be organized under the General Corporation Law of the State of Florida.

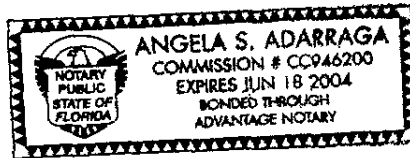
