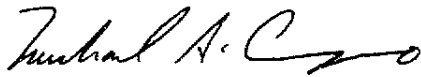

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment adopted: (To replace or amend Article I) The name of this corporation is: Attorney Finders, Inc.

The date of the amendment's adoption: March 24, 2003.

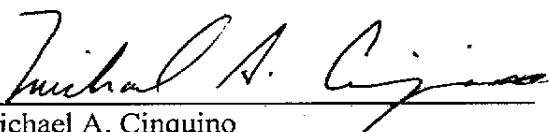
SECOND: Amendment adopted: (To replace or amend Article III) The maximum number of shares this corporation is authorized to issue is 100,000, par value \$.01 per share, all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders of common shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

The date of the amendment's adoption: March 24, 2003.

THIRD: Adoption of Amendment:

The amendments were adopted by the incorporators without shareholder action. No shares have been issued as of this date, and hence shareholder action was not required.
