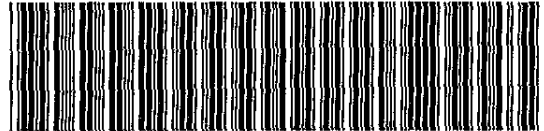

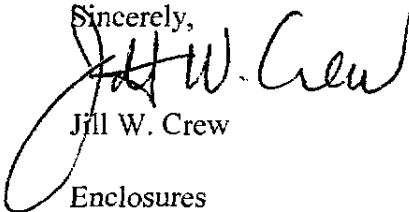

OF

In compliance with the requirements of F. S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

Article I

The name of the corporation (the "Corporation") is Liberty Custom Furnishings, Inc.

**Article II
Principal Office**

The principal place of business and mailing address of the Corporation is: 505 Mountain Drive, Unit K, Destin, FL 32541.

**Article III
Authorized Shares**

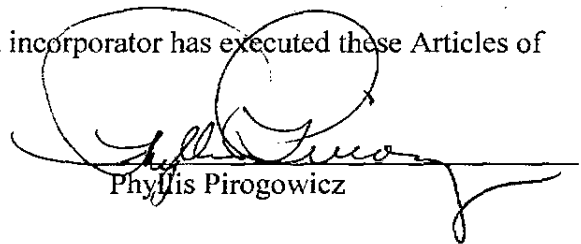

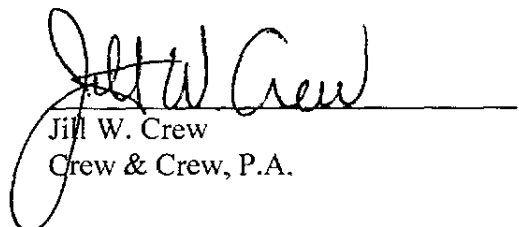
