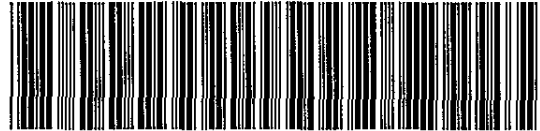

ARTICLES OF INCORPORATION

OF

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE:
SILVESTRE, INC.

ARTICLE II

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE.

ARTICLE III

THIS CORPORATION IS ORGANIZED FOR THE FOLLOWING PURPOSES:

- A. TO ENGAGE IN CARPET SERVICES OF ANY TYPE OR NATURE
TO SELL OR TRADE ALL ITEMS RELATIVE TO CARPET SALES
TO INSTALL CARPETS ANG LIKE PRODUCTS.
- B. TO BUY, SELL, TRADE, DEAL IN,LEASE, OPERATE, HOLD OR
