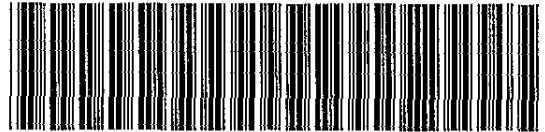

**ARTICLE I
PROFESSIONAL ASSOCIATION NAME AND PRINCIPAL ADDRESS**

The name of this professional association is Melinda P. Tindell, P.A., and the initial principal address of the professional association is 1370 Pinehurst Road, Dunedin, Florida 34698.

**ARTICLE II
NATURE OF BUSINESS AND POWERS**

The general nature of the business transacted by this professional association is to engage in the practice of law and any and all business which a legal professional service professional association is permitted under the laws of the State of Florida and the Rules regulating the Florida Bar.

**ARTICLE III
CAPITAL STOCK**

The maximum number of shares of capital stock that this professional association is authorized to issue and have outstanding at any one time is 10,000 shares of common stock having a par value of \$1.00 per share.

**ARTICLE IV
TERM OF EXISTENCE**

This professional association shall have perpetual existence.

**ARTICLE V

This professional association shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by bylaws adopted by the stockholders, but shall never be less than one (1).

ARTICLE VII
INITIAL DIRECTORS

The person named as initial director shall hold office for the first year of existence of this professional association or until a successor is elected or appointed and has qualified, whichever is first.

ARTICLE VIII

ARTICLE IX
AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders' meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.



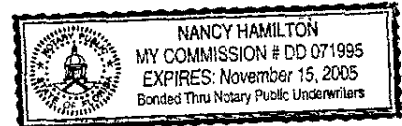


