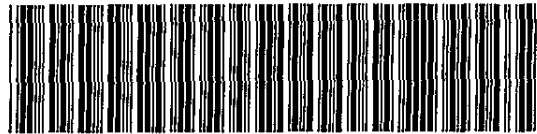

ARTICLES OF INCORPORATION

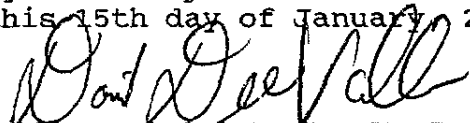

- ARTICLE I The name of this corporation is MADISON TRANSPORTING CORPORATION.

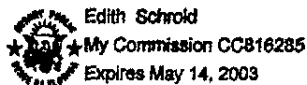
