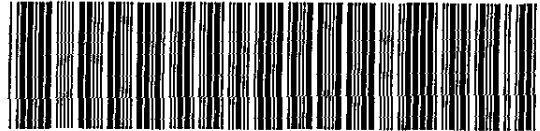

ARTICLE I.
NAME

The name of this corporation is The Gibson Group, Inc.

ARTICLE II.
PRINCIPAL OFFICE

The principal office and mailing address of this corporation is: 399 150th Avenue, #203, Madeira Beach, FL 33708.

ARTICLE III.
DURATION: EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of the date of filing with the Secretary of State.

ARTICLE IV.
PURPOSES

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

ARTICLE V.
CAPITAL STOCK

This corporation is authorized to issue **Ten Thousand (10,000)** shares of **One Dollar (\$1.00)** par value common stock.

ARTICLE VI.
REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE VIII.
INCORPORATOR

AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
