

ARTICLES OF INCORPORATION OF PATRICK A. CAIRNS, P.A.

ARTICLE I. NAME

The name of this corporation shall be Patrick A. Cairns, P.A.

ARTICLE II. COMMENCEMENT & DURATION

The Commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Department of State. This Corporation's duration shall be perpetual.

ARTICLE III. PURPOSE

This corporation is being organized for the purpose of engaging in the Practice of Law and all business activities permitted under the laws of Florida and United States of America for a specific purpose, the practice of law.
