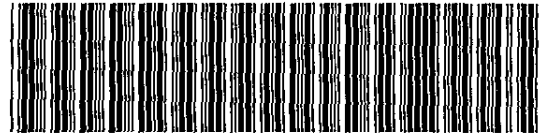

The undersigned subscribers to these Articles of Incorporation hereby form a corporation under the Florida General Corporation Act.

Article I

Name of Corporation

The name of the corporation is: PC-Dispatch, Inc.

Article II

General Purpose

The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act including selling various products via the Internet and otherwise including transportation dispatching software and associated hardware. In addition the development and creation of these programs as well as the installation of related equipment and maintenance in order to keep these systems running properly is a primary purpose of this organization.

Article III

Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of \$1 per share.


