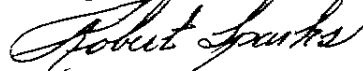

I hereby form a stock corporation under the provisions of Chapter 607 of the Statutes of Florida and to that end set forth the following:

1. The name of the Corporation is **CYBER SOURCE, INC.**
2. The Corporation is organized for the following purposes:
 - a) To establish, operate and promote the business of providing computer materials, training and services not inconsistent with the law.
 - b) To acquire, own, hold, sell, lease, pledge, mortgage or otherwise dispose of any property, real or personal, necessary for the operation of this Corporation;
 - c) To borrow money, contract debts, make contracts, and to exercise any and all other powers as a natural person could lawfully make, do, perform or exercise which may be necessary, expedient or convenient for the accomplishment of any of its objectives or purposes, providing the same be not inconsistent with the laws of Florida and including but not limited to, such other general powers as authorized by Florida Statute 607.0302 as amended.
3. The aggregate number of shares which the Corporation shall have the authority to issue and the par value per share, which shall constitute the shares with voting rights, are as follows:

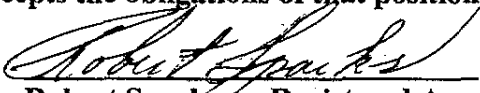

5. That no preemptive rights are granted to the shareholders.

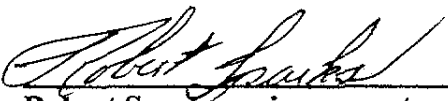
6. The office of the registered agent street and mailing address is the same
