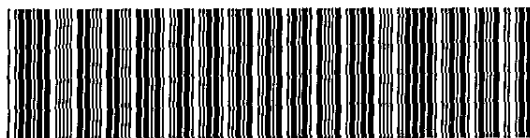

The undersigned subscriber to these Articles of Incorporation, competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation is K & M INVESTMENTS OF CENTRAL FLORIDA, INC., whose mailing address is: P.O. Box 584, Eagle Lake, Florida 33839 and whose physical address is: 4790 Sugarfoot Avenue, Lake Wales, Florida 33859.

**ARTICLE II - PURPOSE**

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE III - CAPITAL STOCK**




