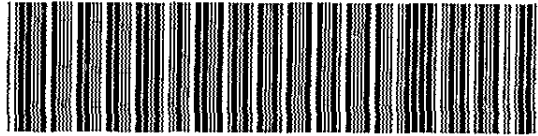

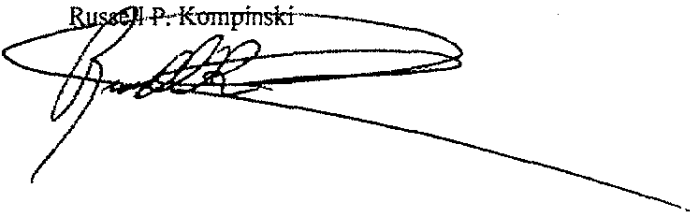

OF

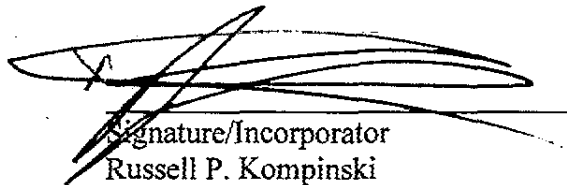

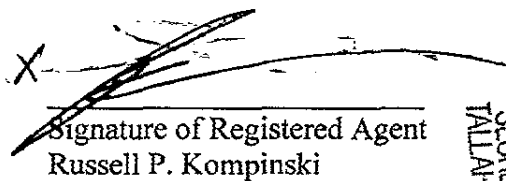
