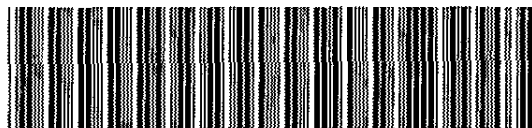

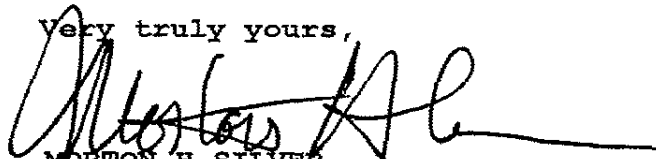

ARTICLES of INCORPORATION

The undersigned incorporator(s) under these Articles of Incorporation, in order to form a corporation under the laws of Florida, hereby certify:

ARTICLE 1 - The name of the corporation is:

STARDOM BARBER SHOP, Inc.

ARTICLE 2 - This corporation is to exist perpetually.

ARTICLE 3 - The general purposes for which this corporation is organized is:

(a) To own, control, operate and engage in the business of a barber shop, and every other kind of barber business, both at wholesale or retail, as principal or agent; including, but not limited to barber schools, barber supply manufacturing and any other business in connection therewith and furnishing every kind of support service thereto.

(b) To own, control, operate and engage in a maintenance, service and supply business for every kind of barber business both at wholesale or retail, as principal or agent; including, but not limited to the manufacture, design, inspection, repair, modification, improvement, alteration, conversion, overhaul, buying, selling, leasing, importing and exporting of barber equipment and supplies of all kinds and types whatsoever, and all component parts thereof and accessories thereto.

(c) To carry on the business of import and export of barber equipment, supplies and general barber merchandise, goods and wares and any other goods, merchandise or products of every kind and description related thereto in all foreign and domestic markets; and to act as consultants, brokers, commission men, factors and agents for buyers and sellers, both foreign and domestic in connection therewith. To purchase and sell such barber goods that are permitted by the laws of the United States to be handled in interstate commerce, and world foreign trade. To acquire, use, and operate equipment, materials, and supplies, and maintain all things necessary to effect the purpose and objectives that are required in this type of business as above and herein generally described.

(d) To do anything which a corporation may lawfully do under the laws of the State of Florida.

ARTICLE 4- The street and mailing address of the initial principal office of the corporation is: 7220 N.W.36th Street, Suite 530, Miami, Florida 33166.

ARTICLE 5- The aggregate number of shares of stock which the corporation shall have authority to issue is 100 shares of no par value, capital stock.

ARTICLE 6- The street address of the initial registered office of the corporation is 24000 Tennessee Road, Homestead, Florida 33031; and the name of its initial registered agent at such address is: Morton H. Silver.

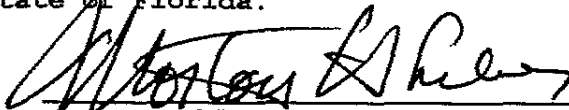
