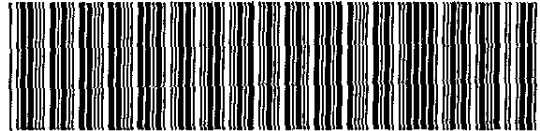

Article I - Name

The name of this corporation is PALM BEACH COUNTY RESEARCH CORP.

Article II - Duration

This corporation shall have perpetual duration commencing on the date of execution of and acknowledgment of these Articles.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Capital Stock

This corporation is authorized to issue 1,000 shares of ONE DOLLAR (\$1.00) par value common stock.

Article V - Preemptive Rights

Every shareholder, upon the sale of any unissued stock of this corporation for cash, assets or other consideration, shall have the right to purchase his or her pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

Article VI - Principal Office; Mailing Address

The street address of the principal office is 301 South K Street, Lake Worth, FL 33460 and the mailing address of the corporation is P.O. Box 5495, Lake Worth, FL 33466.

Article VII - Initial Registered Office and Agent

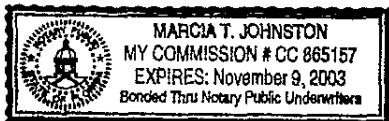
