

ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under HORIUA the Florida General Corporation Act, hereby adopts the following

ARTICLE I. NAME. The name of the corporation is, IMPACT INVESTORS, INC., located at 8924 N.W. 51st Pi., Coral Springs, FL 33067.

ARTICLE II. DURATION. The term of existence of the corporation is perpetual.
