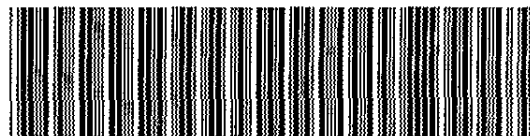

**ARTICLE I. NAME**

The name of the corporation is Doris Davies, P.A..

**ARTICLE II. PRINCIPAL OFFICE**

The principal office of the corporation is 5902 Audubon Manor Boulevard, Lithia, Florida 33547, and the corporation's mailing address is 16765 Fish Hawk Boulevard, No. 153, Lithia, Florida 33547.

**ARTICLE III. PURPOSE**

This Corporation is organized under the Florida Professional Service Corporation and Limited Liability Company Act for the purpose of engaging in the sale, leasing and rental of real estate, for a fee or commission, under the direction or control of another person, and any other activities allowable for a real estate sales person pursuant to Chapter 475 of the Florida Statutes. The corporation may act only through its members, officers, employees, and agents who are duly licensed and otherwise legally authorized to carry out such business under Chapter 475.

**ARTICLE IV. INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of this corporation is 5902 Audubon Manor Boulevard, Lithia, Florida 33547, and the name of the initial registered agent of the corporation at this address is Doris Davies.

**ARTICLE V. INITIAL DIRECTOR**

This corporation shall have one director initially. The number of directors may be either increased or diminished from time to time as provided for in the bylaws, but shall never be fewer than one. The name and address of the director of this corporation are:

#### ARTICLE VI. CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of common stock, having a par value of One Dollar (\$1.00) per share. There shall be only one class of stock.

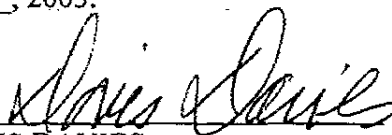
#### ARTICLE VIII. LIMITATION ON CORPORATION'S BUSINESS

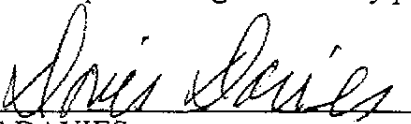

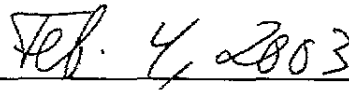
