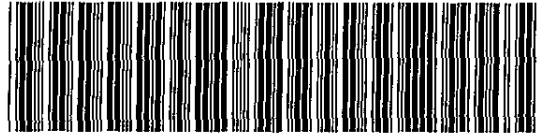

The undersigned subscribers to these articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of this Corporation is:

**ARTICLE II – NATURE – PURPOSE OF BUSINESS**


