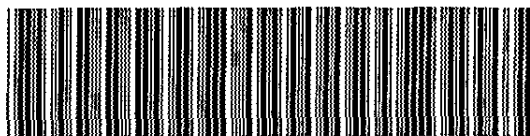

The undersigned incorporator(s) for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be SUMMERFIELD USED AUTO PARTS, INC.

The principal place of business of this corporation shall be 6875 S.E. Highway 42, Summerfield, Florida 34491.

ARTICLE II: NATURE OF BUSINESS




