



ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Third Hand, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 4204 N. Nebraska Avenue
Tampa, Florida 33603

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
